NOTICE IS HEREBY GIVEN that the **LONG BEACH UNIFIED SCHOOL DISTRICT**, acting by and through its Governing Board, hereinafter referred to as "District", will receive sealed bids for the following project(s):

**BID SCHEDULE#: FAC18-1819  
SECURITY FENCING IMPROVEMENTS - PHASE 4 (9 SITES)**

**A MANDATORY PRE-BID CONFERENCE** will be held on **May 2, 2019 at 10:00 am** at the District's Purchasing & Contracts Branch Office located at 2201 E. Market St., Long Beach 90805. There will be a non-mandatory visit to at least one project site immediately following the meeting.

**SCOPE OF WORK:** Provide all labor, materials and equipment for the installation of ornamental and chain link fencing at nine (9) school sites, per the bid drawings/specifications.

**AWARD:** This project is to be awarded to the lowest responsible, responsive bidder.

**PROJECT DURATION:** **60** consecutive calendar days.

**LICENSE REQUIREMENTS:** At the time bids are submitted, each bidder shall possess a valid class **C-13** contractor's license and must maintain the license throughout the duration of the project.

**ESTIMATED PROJECT COST:** Total Estimated Project Cost for Nine (9) Sites: **\$740,000**, as follows:

**BID OPENING:** Sealed bids must be received prior to **2:00 pm on May 16, 2019** at the **District's Facilities Development & Planning Office located at 2425 Webster Ave., Long Beach 90810** at which the bids will be opened and publicly read aloud. Bids shall be on the form provided by the District and each bid must conform and be responsive to the Contract Documents as defined in the General Conditions. Any bid submitted after this time shall be non-responsive and returned to bidder.

**PREVAILING WAGES:** The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: [www.dir.ca.gov](http://www.dir.ca.gov). Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

**BID SECURITY:** A Bid Security of 10% of total bid amount is required to be submitted with bid form. Successful Bidder will be required to furnish 100% Payment and Performance Bonds.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
